- ➤ The purpose of this methodology is the organization of schooling at home, namely the creation of groups / classes in hospitals, as forms of education adapted in accordance with the law ..
- ➤ The purpose of schooling at home and in hospitals is to give them the students are unable mass school attendance the opportunity to achieve a level of education corresponding individual particularities premise of good social and professional integration.
- > The beneficiaries of these forms of education adapted are children / homebound students with chronic illnesses or diseases that require long periods of hospitalization, with or without other associated deficiencies which, temporarily or permanently can not attend Mass
- > Specifics education at home and in hospitals is the adaptation of the educational process development opportunities individual education of each child and the environment in which this process takes place

- > The objectives pursued by home schooling or through the creation of groups / classes in hospitals are:
- a) ensuring continuity of schooling, allowing the student to promote academic year in progress or participate in evaluations organized for completing a level of education;
- b) b) the creation and development of a good communication between the school environment and the children, students and young people schooled at home / hospital;
- c) c) providing the joint action of health professionals and teachers involved in the recovery and education of students.

Categories of disabilities (impairments) which will consider home schooling, typologically structured according to the Order of the Minister of Health and Family and the State Secretary of the National Authority for Child Protection no. 725/2002 regarding the criteria for establishing the degree of disability for children and apply special protection measures are: a) impairment (impaired) nervous system and overall mental functions;

- b) damage to structures and sensory functions;
- c) impairment of laryngeal structure and functions;
- d) impairment of the structure and functions of the cardiovascular, respiratory and immune;
- e) impairment of the structure and functions of the digestive, metabolic and endocrine;
- f) impairment of the structure and functions of the urinary system;
- g) impairment of musculoskeletal structure and function and proper motion and muscle;
- h) impairment of skin structure, and functions of skin annexes;
- i) damage related to cancer disease;
- j) damage multiple body-related debilitating genetic diseases;
- k) impairment of the body related to organ transplantation.
